

# LONG ISLAND DUCKS GRAND SLAM INNING PROMOTION

## CONDITIONAL PRIZE CONTEST

GAMES 5/5, 5/19, 5/26, 6/9, 6/30, 7/14, 7/28, 8/11, 8/18, 9/1, and 9/15

1. Long Island Ducks will conduct the contest in accordance with the outcome of the Long Island Ducks baseball game on the above listed contest date(s), at location Fairfield Properties Ballpark, for a chance to win the following grand prize:
  - a) \$25,000.00 Cash
2. A finalist will be awarded the \$25,000 cash grand prize if the fourth (4<sup>th</sup>) member of the Long Island Ducks to bat in the 6<sup>th</sup> inning hits an officially scored GRAND SLAM HOMERUN (homerun scored with the bases loaded). **If the fourth (4<sup>th</sup>) member of the Ducks does not record an official grand slam in the 6<sup>th</sup> inning the Long Island Ducks baseball game, no grand prize will be awarded to the finalist who has been selected for that game.**
3. One Entry Per Person.
4. The following restrictions will apply to the occurrence and the contest event covered by this contract:
  - a) The Grand Slam Homerun must be a regulation OUT OF THE PARK homerun. INSIDE THE PARK HOMERUNS ARE NOT ELIGIBLE FOR PRIZE REIMBURSEMENT.
  - b) The grand slam must occur during the 6<sup>th</sup> inning of a game specified on these terms and conditions at the top of the page.
  - c) The grand slam must be recorded by the 4<sup>th</sup> batter of the inning.
5. The following restrictions will apply to the execution of this contract:
  - a) The game covered by this contract must be an official game. If the game is cancelled for any reason prior to becoming an official game all statistics are removed from the official score book; therefore, there will be no claims acknowledged based on this game.
  - b) All outcomes must be recognized as an official play by the umpires at the game, the official scorer and applicable league office. Any outcome which is not ruled and recorded as an official play by the league resulting in one of the occurrences outlined in item 3 will not be eligible for a grand prize award.
  - c) Any change in the official scoring that would result in a winner under the terms and conditions of this contract must be completed prior to the completion of the game. ANY changes to the scoring following the completion of the game that would result in a winner under the terms of this contract will not be acknowledged and no claim will be paid.
  - d) Any play which occurs as the result of a spectator who in any way interferes with an opposing player who is attempting to catch/field the ball (grabbing a player's arm, removing the ball from a player's glove, e.g.) will not constitute a winning play for this contract, irrespective of the official scoring of the play.
6. If there is a grand prize winner, the winner must come to the Long Island Ducks at a mutually agreed date and time at least two weeks prior to the delivery of the grand prize.
7. In the event of a grand prize winner under the age of 18, the grand prize will be awarded to the legal parent or guardian. Current and Former Employees of the Long Island Ducks, other related sponsors, and their immediate families, agents, successors, assignees may not participate and are not eligible to win. The term "immediate families" includes spouses, grandparents, parents, siblings, children, and grandchildren.
8. Persons who have won another contest or promotion of any kind from the Long Island Ducks within 30 calendar days before the contest date are ineligible to win.
9. Difficulties with getting to locations to enter the contest are not the responsibility of the Long Island Ducks.
10. As winner of the grand prize, you will be required to sign a release form before your prize will be awarded. You will be responsible for all applicable title fees, registration fees, and taxes including state, local, and federal and therefore must present a valid Social Security Card before claiming your prize.
11. As a grand prize winner, you acknowledge that the Long Island Ducks and Odds On Promotion have the right to, without further authorization, publicize your name, character likeness, photograph, voice, and the fact that you are a grand prize winner for promotional purposes without financial remuneration.

13. Grand prize winner will be randomly selected from all pre-game entries. Pre-game entry must be filled out by a ticketed holder to the corresponding promotional date of contest. 18. The Long Island Ducks, their representatives, agencies, and employees are not responsible for any liabilities arising directly or indirectly from the award or use of the prize.
19. The Long Island Ducks, their representatives, agencies, and employees are not responsible for any changes or difficulties in travel, lodging, ticket arrangements, or prize delivery.
