CONDITIONAL PRIZE CONTEST

- 1. Long Island Ducks will conduct the contest in accordance with the outcome of the Long Island Ducks baseball game on the above listed contest date(s), at location Fairfield Properties Ballpark, for a chance to win the following grand prize:
 - a) \$25,000.00 Cash
- 2. A finalist will be awarded the \$25,000 cash grand prize if a triple play is recorded during the Long Island Ducks game. If a triple play occurrence is <u>not</u> recorded during the Long Island Ducks baseball game, no grand prize will be awarded to the finalist who has been selected for that game.
- **3.** One Entry Per Person.
- 4. The following restrictions will apply to the occurrence and the contest event covered by this contract:
 - a) A triple play shall occur when (and only when) all three outs are recorded by the Long Island Ducks during a single continuous play.
- 5. The following restrictions will apply to the execution of this contract:
 - The game covered by this contract must be an official game. If the game is cancelled for any reason prior to becoming an official game all statistics are removed from the official score book; therefore, there will be no claims acknowledged based on this game.
 - b) All outcomes must be recognized as an official play by the umpires at the game, the official scorer and applicable league office. Any outcome which is not ruled and recorded as an official play by the league resulting in one of the occurrences outlined in item 3 will not be eligible for a grand prize award.
